Death Sentence	A sentence in which the individual is sentenced to death. This only applies to individuals convicted of murder in the first degree.	"Death" is checked
Determinate (Fixed) Term	A prison term in which a judge must designate a portion of the sentence as the determinate, or fixed, term. During the determinate term, the individual is not generally eligible for parole or discharge.	Number entered in Years, Months, and/or Days box
Indeterminate Term	A prison term in which the judge must designate a portion of the sentence as the indeterminate, or unfixed, time. After the individual has served the determinate term, they may be considered for parole, discharge, or continue incarceration on the indeterminate portion of the sentence.	Number entered in Years, Months, and/or Days box
Life Sentence	A sentence in which prison is imposed for the remainder of the individual's life.	"Life" is checked OR indeterminate term is greater than or equal to 99 years
Probation	An alternative to incarceration ordered by the Court as a result of suspending the sentence of the individual convicted of a felony offense and granting that individual the opportunity to remain in the community subject to specified terms and conditions, in lieu of imprisonment. Can include jail term or discretionary jail term.	Probation conditions are entered, "Retained Jurisdiction" is not checked, Withheld Judgment type is not selected, and prison term (determinate and/or indeterminate confinement term) is not imposed
Retained Jurisdiction (Rider)	A sentence in which individuals are incarcerated in an Idaho Department of Correction (IDOC) facility but are under the Court's jurisdiction for up to three hundred and sixty-five days as they receive treatment and programming. Within that 365-day time period the Court may suspend the sentence to the IDOC and place the individual on probation, or the Court may relinquish jurisdiction, which results in the individual being required to remain in the custody of the IDOC and serve their sentence.	"Retained Jurisdiction" is checked
Sentence Executed	A sentence in which the individual is placed in the custody of the Idaho Department of Correction.	Prison term (determinate and/or indeterminate confinement term) is greater than 0 or "Life" or "Death" is checked, "Retained Jurisdiction" or "Penitentiary Suspended" are not checked, and Withheld Judgment type is not selected
Withheld Judgment	A sentence in which a judge orders that a judgment is withheld. If the individual complies with the terms of probation, he or she may then file a motion to withdraw their guilty plea and obtain a dismissal of the case from the court. May be granted after conviction and guilty plea.	Withheld Judgment type is selected

	Domestic Violence	A domestic violence crime is a crime involving violent behavior towards a household member, including assault, battery, or violation of a protection order.
	Elder Abuse	An elder abuse crime is a crime related to the abandonment, abuse, neglect, or exploitation of a vulnerable adult.
	Rape/Sexual Assault/Battery	A rape/sexual assault/battery crime is a sexual crime in which the victim is not a household member of the offender. This encompasses rape, sexual battery, and forcible penetration by use of a foreign object.
	Weapon	A weapon crime is a crime related to unlawful purchase, possession, discharge, exhibition, or transport of a weapon, as well as threats of violence related to a weapon. Weapons include, but are not limited to, firearms, bombs, explosives, destructive devices, and chemical or biological weapons.
	Other Crimes Against Persons	This subcategory encompasses crimes against persons that do not fall into one of the above subcategories. This includes murder, manslaughter, robbery, and injury to children, as well as harassment, stalking, eluding a police officer, recruiting a gang member, and assault or battery that is not considered domestic violence or sexual abuse.
